Dear President Sheets and Members

My report will be brief tonight:

1. Since January 1, 2010 seventeen firefighters have died in the line of duty in the US and Canada.
2. A 32 YO West Virginia Firefighter drown during a swift water rescue last week. Donald Adkins of the Glasgow W. VA Fire department apparently fell out of a boat while working in a swift water rescue situation. His body was found approximately 5 miles down stream from where he fell in.
3. A 40 YO veteran LA city firefighter had a near drowning emergency while in a swift water training exercise this week. Dave Danielson entered the water and struck his head. While being rescued, the firefighter was initially unconscious but due to rapid medical care by fellow firefighters was released from the hospital with in a few hours.
4. The national weather service ranks flash floods as the most likely cause of death for victims and rescuers of any weather event. April, May and June are peak months for flash floods and severe weather in our region.
5. Across the nation, a 38 YO New Mexico Firefighter from the Farmington Fire Department training officer has resigned after pleading no contest to his second DUI charge. Does your department have a DUI Policy?
6. An Ann Arbor Michigan firefighter with 19 years on the job has been suspended and faces termination fro failing to notify his department about his driver's licenses being suspended. The fire department found out when the insurance company did a routine check of drivers and there licenses status. Seams this guy had his licenses suspended seven times in the five years and forgot to let anyone know about it. How often does your department check out your drivers?
7. Lyndon Fire District in Jefferson County has requested permission from City of Louisville Jerry Abramson to start providing ambulance service to his customers. The need for additional revenue and improved service to the Lyndon customers are the main reasons for this request.
